The Annual Budget Vote & School Board Election is scheduled for **Tuesday, May 19, 2026**.

The Peru Central School District is seeking candidates to fill two (2) at-large seats on the Board of Education. These vacancies result from the upcoming term expiration of Mr. Mark Hamilton and the resignation of Ms. Sarah Mitchell, which is currently filled by Mr. Steven Peters.

A three-year term beginning July 1, 2026, and ending June 30, 2029.

A two-year term to complete a vacated seat, beginning July 1, 2026, and ending June 30, 2028.

The elected candidate who receives the most votes will be granted the three-year term.

**AT LEAST TWENTY-FIVE (25)** signatures of qualified voters of the Peru Central School District are required for the petition to be considered for nomination.
